Similar Schools

Similar Schools are a group of Victorian government schools with similar characteristics to the school.

This grouping of schools has been created by comparing each school's socio-economic background of students, the number of non-English speaking students and the school's size and location.

NDP and NDA

'Levels A to D' may be used for students with disabilities or students who may have additional learning needs. These levels are not associated with any set age or year level that links chronological age to cognitive progress (i.e., there is no age expected standard of achievement for 'Levels A to D').

NAPLAN

The previously reported NAPLAN 4-year average will not be available until 2026, when there will be 4 years' worth of NAPLAN data available under the new methodology. Similarly, 2023 NAPLAN Learning Gain data will not be available until 2024 as the measure requires a comparable two-year prior result as a point of comparison.

Parent/Caregiver/Guardian Opinion Survey, School Staff Survey and the Attitudes to School Survey

The calculation of the percentage endorsement for all survey measures has been revised to no longer include skipped responses. This applies to all survey measures reported in the Performance Summary. The change to the calculation reduces the negative impact of skipped responses on school results, particularly where there were a small number of respondents to the survey.

Additionally, the Parent Satisfaction measure has been revised to use the percentage endorsement of the 'General School Satisfaction' factor of the Parent/Caregiver/Guardian Opinion Survey only. Previously, this measure reflected an average of multiple factors in the survey. The change to reporting a single factor is consistent with how Parent Satisfaction is reported to schools and in other public reports.

About Our School

School context

Hesket Primary School opened in 1870 and in 2023, finished the year with an enrolment of 59 students, arranged into three multi-age classes. The school is situated in Hesket, nestled between Hanging Rock and Mount Macedon. The school has an SFOE of 0.2500 with the students coming from the townships of Lancefield, Romsey, Woodend and Kyneton as well as many second-generation farming families from the local areas of Hesket, Rochford, Newham and Kerrie.

In 2023 the staffing profile consisted of a principal, three full-time teaching staff (3.0), two part time specialists (0.4), an Art Therapist (0.2), Literacy and Numeracy Intervention 0.6 and four Education Support staff (2.5). The 2023 grade structure included a Grade Prep/One composite of 15 students, a Grade One/Two composite of 20 and Grade 3-6 composite of 22. The school plans and implements a broad curriculum that provides opportunities for students to experience success across a range of academic, artistic, sporting, social and science programs. Specialist programs included weekly Art, Science, Leadership, PE (supported by the Sporting Schools program) and Auslan. The school continued to be a member of the Great Southern MARC scheme – providing a Literacy based program with a trained teacher librarian. Students were offered the opportunity to participate in leadership and extension programs such as Kids Teaching Kids, Maths Olympiad, Tournament of Minds alongside sporting opportunities. Hesket prides itself in its commitment towards inclusive education and an undertaking to provide differentiated learning programs. Every student spends quality time with a teacher or Education Support Staff each day with personal and learning conversations leaving students feeling 'noticed' and that their learning is important. The school philosophy is based on the belief that all students, given the right support, have the ability to achieve their full potential.

Student Welfare has a high priority with a focus on every student and staff member having a place in our school community. Language modelled to students often begins with, "At Hesket we..." where there is a collective expectation for interactions that all staff and students have with one another. This also extends to a general pride in the behaviour and standards that students have for the work they produce. In 2023 student well-being was supported by the appointment of an Art Therapist who worked alongside students to share feelings while being expressive and creative.

Many opportunities are provided for Student Leadership, with a growing focus on students being in an environment where they have opportunity and are responsible for their learning and behaviour. From Prep, students experience elements of leadership, helping to host student assemblies and developing confidence in the playground.

In 2023, the school's before and after care program was run by School's Out and offered to all students who required it. This program was well attended and ran nine sessions throughout the week.

Progress towards strategic goals, student outcomes and student engagement

Learning

2023 showed that Hesket was a school of choice with many parents selecting the school for its strong academic programs, in particular Literacy. The school added to Department funding to provide intervention for students falling below learning benchmarks or who had not made projected growth. These students accessed extra support via the Tutoring Learning Initiative in the areas of Literacy as well as Numeracy. Literacy intervention included students participating in the SPAIDES program (Speech delivered by an AIDE), synthetic phonics and Mathematics intervention programs.

Those students who have been identified as not making at least 12-months growth in 2023 will receive extra support in 2024 via the Tutor Learning Initiative.

Hesket remains very proud of its approach to Literacy with students showing high-levels of proportionate growth and student achievement using Departmental assessments such as NAPLAN and PAT assessments.

Wellbeing

As a small school, where knowing our students academically, emotionally and socially is a priority, Wellbeing continues to be a strength of the school. We are very proud of our feedback from parents and students in relation to the culture and climate that the 2023 staff have set at Hesket. There has been clear communication from the school to students and their families that there is an

increased academic expectation of students with high-quality teaching to support this. We hold a belief that Wellbeing and Achievement are intrinsically linked.

94% of students responded to have a positive Sense of Connectedness with their school and 89% of students responded positively to the Management of Bullying. Both of these areas continue to be strengths, being significantly higher than the state and similar schools averages.

Small grades ensure all students are 'visible' and any wellbeing challenges that may present are quickly observed and addressed. Utilising communication platforms such as Seesaw creates an authentic link between home and school and provides an easy communication tool. Genuine relationships and open communication between school and home remain key to Hesket's success.

Engagement

The strong teacher and student relationships support student learning and this evidence is clear in the Student Attitudes to School Survey.

Evidence that supports a sense of belonging is also documented in the Student Attitudes to School Survey. 100% of students feel proud about being a student at this school. 100% also stated that my teacher makes sure all students feel included.

School relationships are also visible when families regularly respond to the online Seesaw platform photos shared.

Onsite participation from families at school events is high, whether this be a welcome breakfast or an open classroom event.

Student Absence remains higher than similar schools and state averages with an average of 22.9 days were student. Family holidays has the biggest factor on student attendance data.

Other highlights from the school year

Appointment of an Art Therapist to work with students and cohorts across the school.

Quarterly access to the Sporting Schools grants that have given students access to specialist coaches in basketball and gymnastics as well as subsidising travel costs for swimming lessons.

A whole school outdoor ed camp to PGL in Kyneton.

A vibrant and creative school performance of Hesket's Got Talent.

Participation in community events such as the Kyneton Show Writing Competition and Scarecrow competition.

Discovery Centre,

Maths Olympiad extension Maths group.

A Tournament of Minds teams competing at both Regional and State championships.

An excursion to Her Majesty's Theatre to see Mary Poppins.

A higher proportion of students being selected for VHAP extension and enrichment program.

Financial performance

2023 saw Hesket Primary School begin the year with 55 students and finish the year with 59. Through careful management of the SRP in 2022 we had a healthy cash surplus of \$67,290.06 and credit of \$28,040 to roll over into 2023. The following grants were received in 2022: Sporting Schools which funded sports coaches in basketball, swimming and gymnastics \$4117, the bushfire program which funded grounds cleanup, annual bushfire prevention and building maintenance to the value of \$20,626.75, Earthwatch \$2700 and a Junior Landcare grant of \$1000. A dedicated group of parents fundraised \$5367.27 which subsidised the 2023 whole school camp.

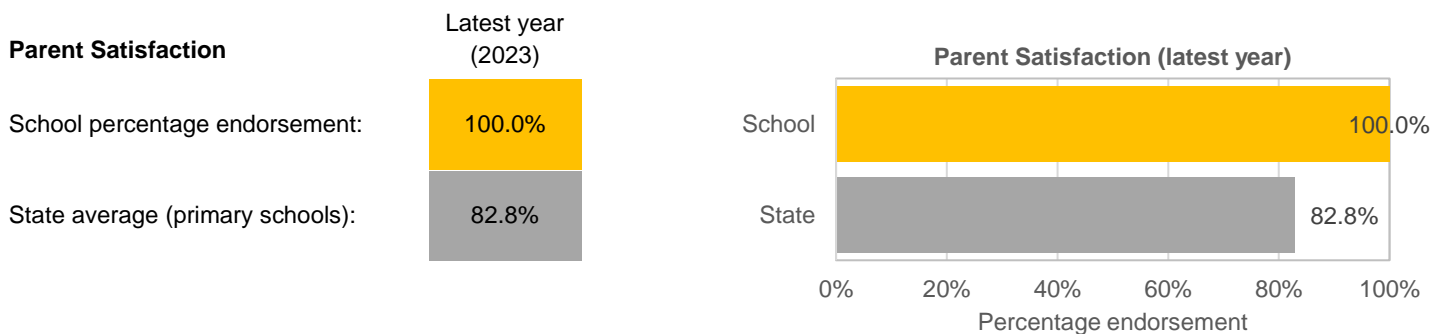

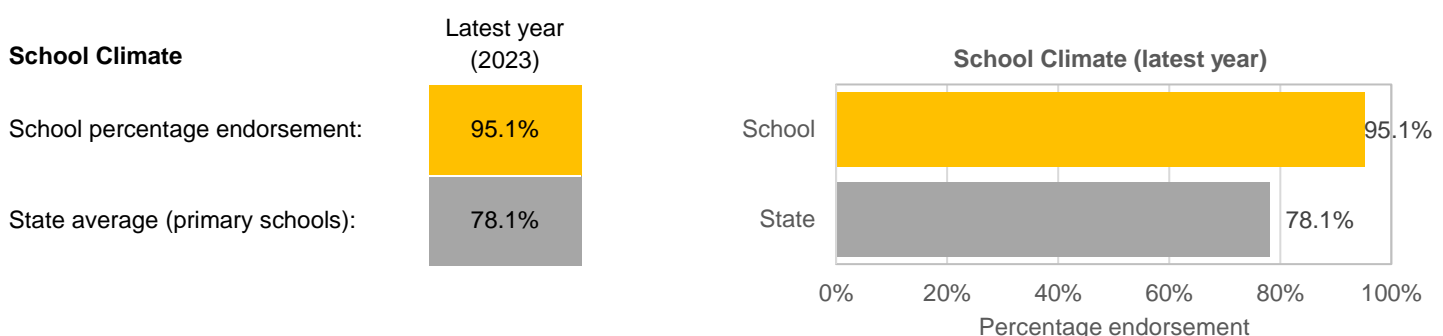

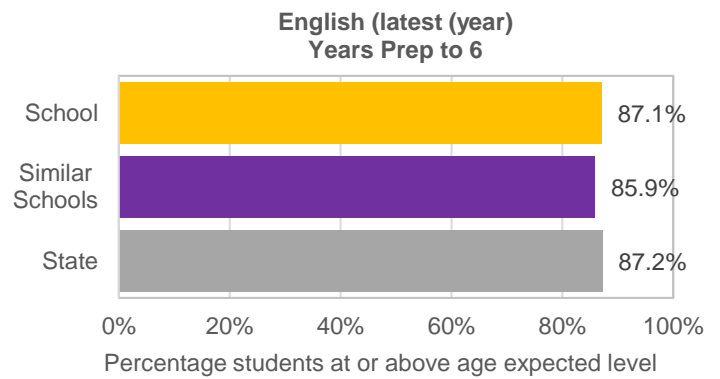

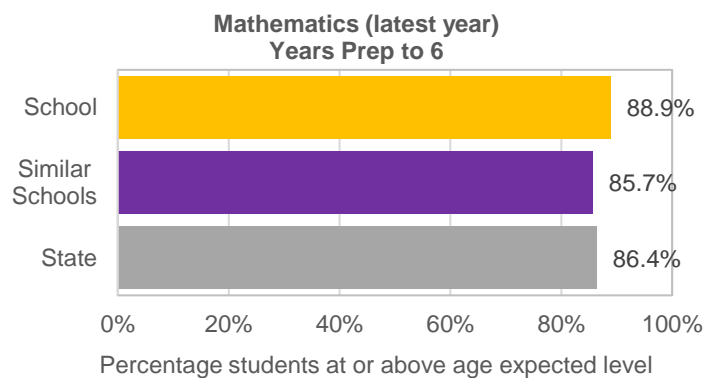

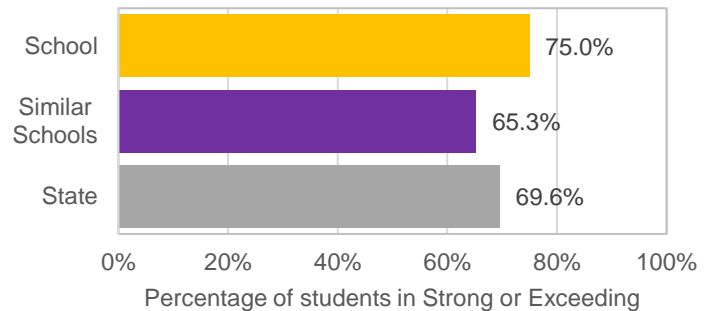

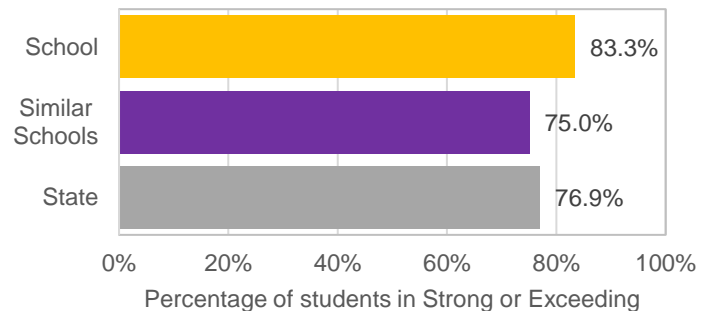

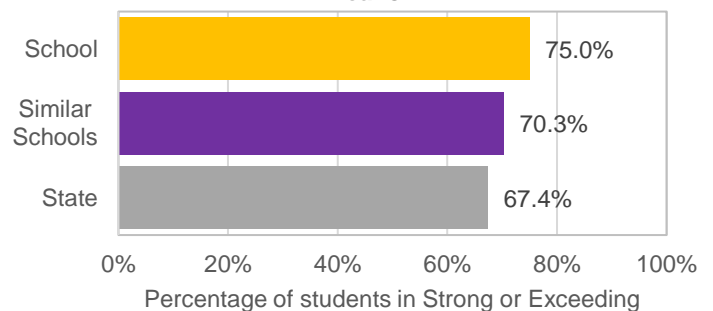

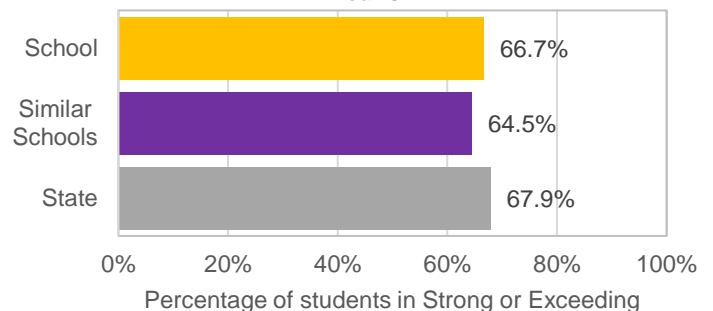

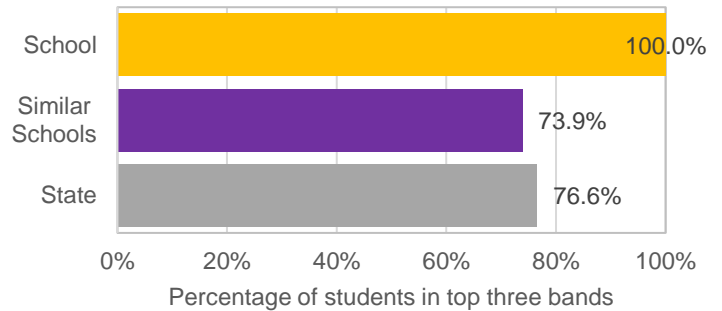

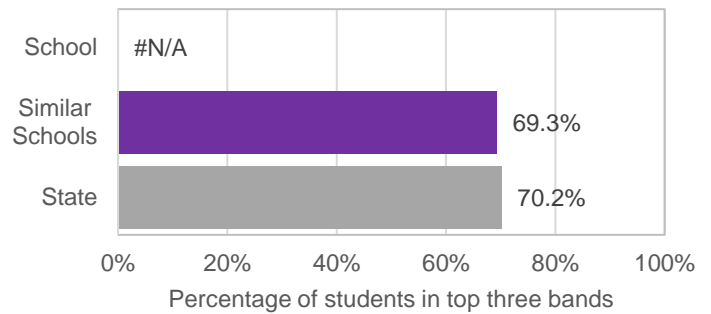

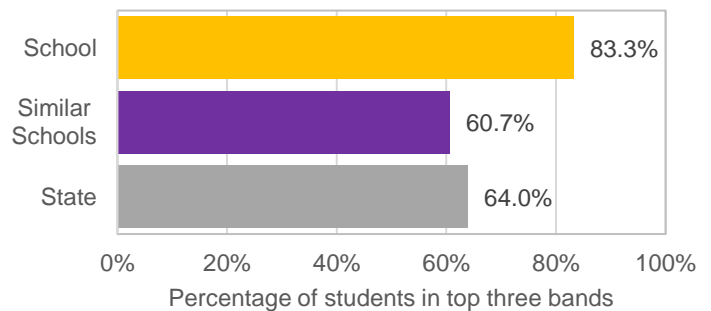

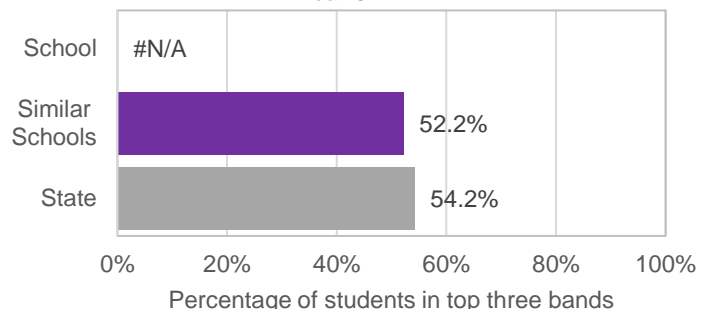

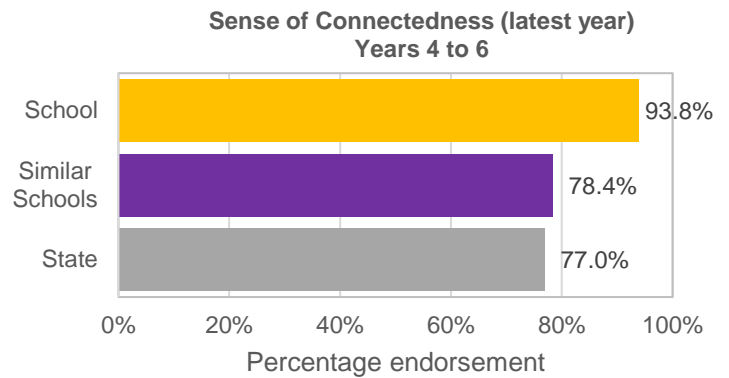

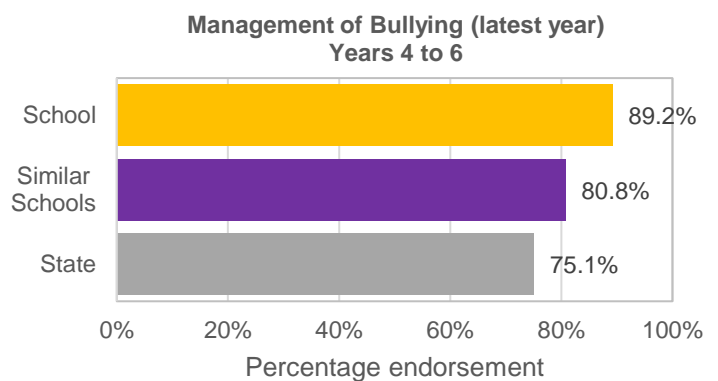


Student Attitudes to School – Management of Bullying

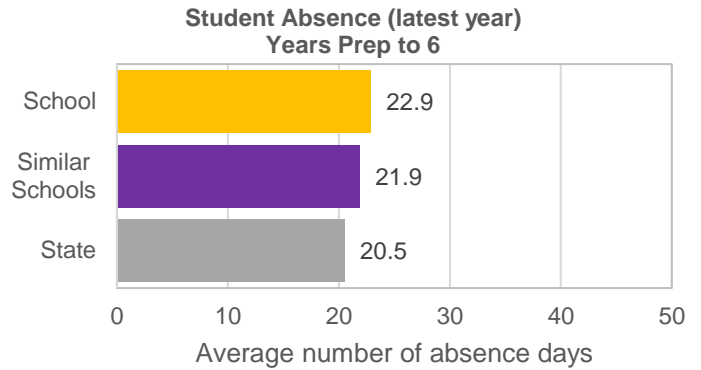
